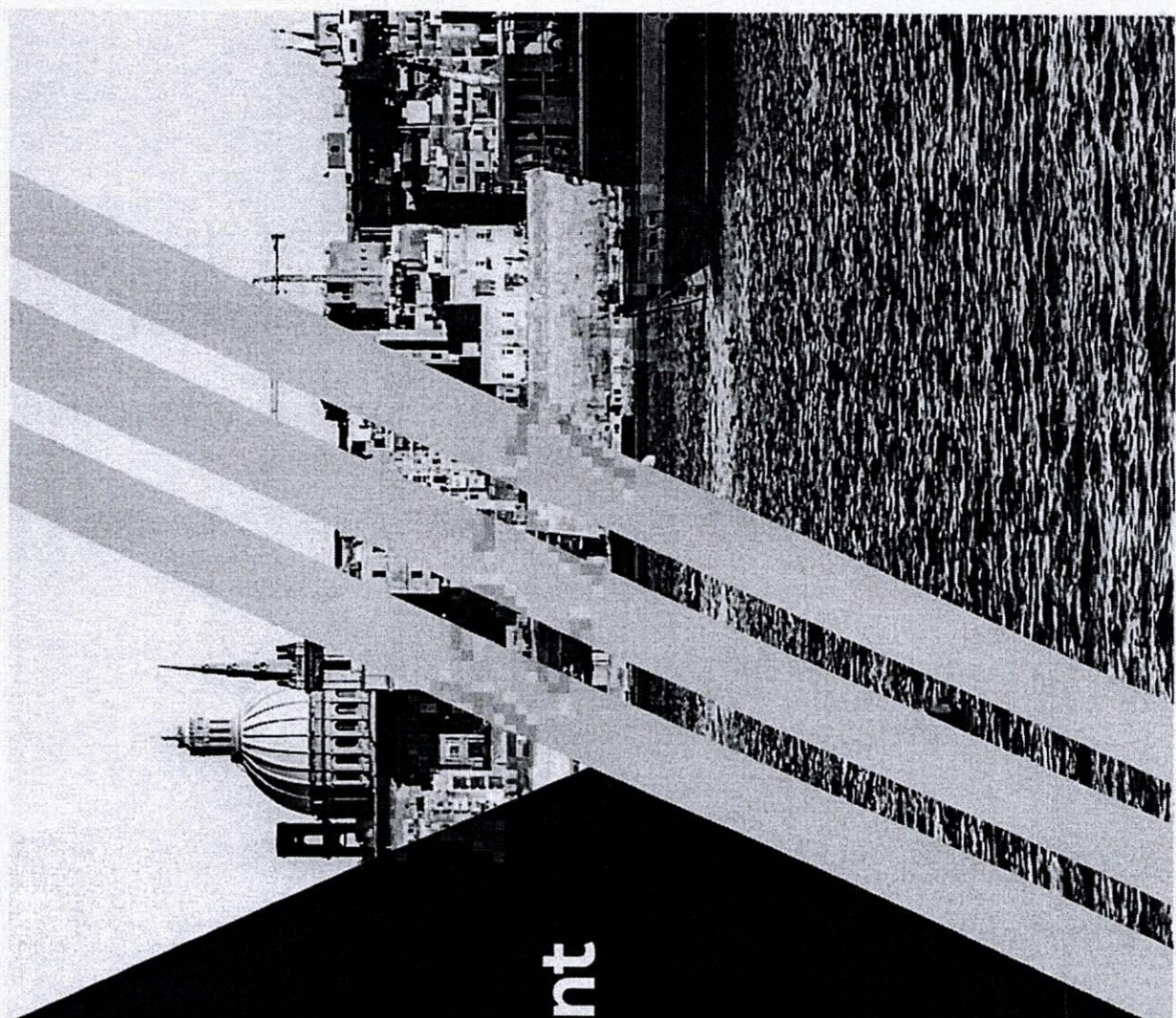

Energy – energy transition, green and conventional solutions, transregional energy interconnectivity.

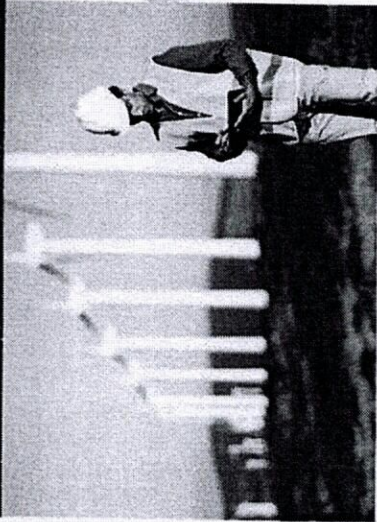
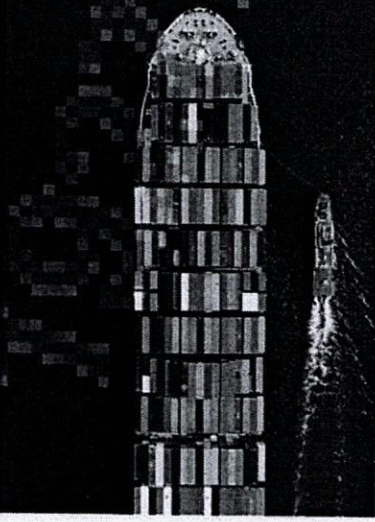
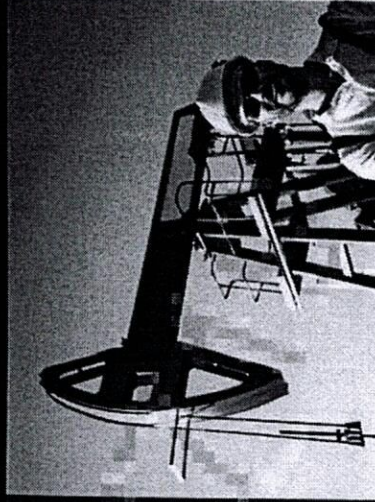
Construction and infrastructure – sustainable urban development, industrial and logistic infrastructure.

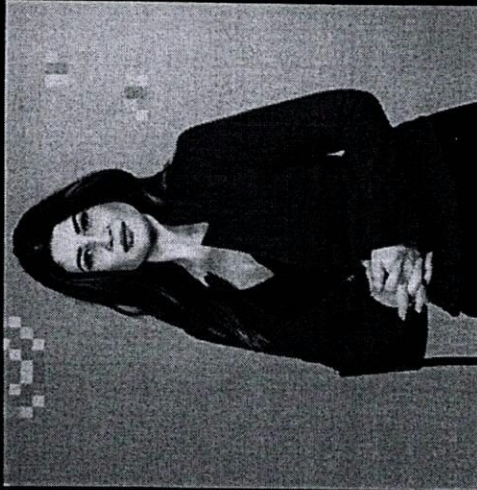
