**Launch of New Form of Non-Preferential Certificates of Origin
(with ICC label)**

Hereby The Ukrainian Chamber of Commerce & Industry informs you that starting from May 2025 the chambers of commerce & industry in Ukraine will issue a **new form of non-preferential certificate of origin with ICC label** (Attachment 1).

The existing form of non-preferential certificate of origin (Attachment 2) will remain in use until its full usage but no later than January, 1, 2026.

The new form like an existing one can be issued on paper or electronically (e-certificate).
